3 devise? and bequeath to my dear **wife Deborah JUBB** her heirs, executors, administra-
4 tors and consigns all my household furniture, linen, plate, wines and goods in my
5 dwellinghouse and also all my messuages dwellinghouses and tenements in Silver
6 in Halifax aforesaid with their? appurtenances to and for her own use forever. I give and
7 bequeath to my **nephew Abraham JUBB** the sum of two hundred pounds to be paid
8 twelve months after my death and also the contents? of my Surgery including ...
9 ... Library and Surgical Instruments I give and bequeath to my faithful assistant
10 **James ...** the sum of one hundred pounds to be paid twelve months after my death
11 and to **Francis Alexander LEYLAND** one of my executors hereafter named the sum of
12 ... Guineas. I give ... and bequeath unto my said **wife Deborah, my nephew**
13 **Abraham JUBB** and my friend **Francis Alexander LEYLAND** of Halifax I hereby
14 appoint Executix and Executors of this my will. All the Residue of my ...
15 and personal estate whatsoever and wheresoever? to hold to them their heirs exe-
16 cutors and administrators respectively upon trust to permit my said wife to enjoy
17 the same during her life subject to the two annuities hereinafter mentioned namely
18 to my **brother Frank JUBB** the ... yearly sum of twenty pounds sterling for his own
19 use and benefit for and during the term of his natural life and a similar ... an-
20 nuity of twenty pounds Sterling unto my **brother Joshua JUBB** for the term of his
21 life and I ... the said annuities be paid quarterly and I ... that my said
22 trustees or the survivors or survivor of them his or her heirs executors or ad-
23 ministrators shall when and as ... he or she shall think fit absolutely sell and
24 dispose? of the said residue of my said estate and convert the same into money and
25 shall give official? receipts? and discharges? to all purchasers thereof? and shall stand
26 possessed of the ... and ... thereof? (which I desire to be invested in ...
27 ... or other securities trust to pay the annual interest thereof to my
